Vendor shall be bound by all conditions, rules and regulations stated herein or otherwise established by STRUTZFEST.

- 1. READ THE INFORMATION BELOW
- 2. SIGN AND INITIAL WHERE NECESSARY.
- 3. RETURN CONTRACT, PAYMENT, BUSINESS LICENSE. FOOD VENDORS MUST PROVIDE A COPY OF LIABILITY INSURANCE. NO CONTRACT WILL BE ACCEPTED WITHOUT THE PROPER PAPERWORK AND PAYMENT.
- 4. ALL DOCUMENTS AND PAYMENT MUST BE RECEIVED NO LATER THAN JULY 1, 2012.

EVENT DATES ARE FRIDAY AUGUST 3 & SATURDAY AUGUST 4, 2012

Vendor agrees to be set up no later than 10:00am on Friday, August 3, 2012. NO REFUNDS WILL BE GIVEN FOR ANY REASON.

FOOD VENDORS: Snohomish County Health permit is required. Call 425-339-5200 for information.

All extension cords must be Labor & Industries approved and properly secured. If you are cooking food or using a generator, fire extinguishers with a current inspection tag are required.

VENDOR FEES: Food & Craft \$200.00 for one (1) 10 x 10 space. You may buy as many spaces as needed. A \$50.00 fee will be charged for all returned checks. Two (2) weekend passes provided, per vendor, per space purchased. Vendor booths must be properly staffed during the event. Power may be available. STRUTZFEST, does NOT supply tables, chairs, power cords, lighting, water hoses, awnings, etc. You must bring your own supplies. Fee includes one (1) camping site for maximum 4 people.

<u>Vendor load-in must be completed no later than 9:00am</u> Friday August 3, 2012. Vendors may begin setting up as early as Thursday August 2, 2012 at 12:00pm. Vendors may not load-out before the event is over. All vendors must be vacated no later than 3:00pm on Sunday August 5, 2012. ALL VENDORS will deposit trash in the proper receptacles. VENDORS will be billed for the collection of excessive trash or grease.

NO ANIMALS ALLOWED. NO EXCEPTIONS. YOU WILL BE ASKED TO LEAVE.

NO WEAPONS OR DRUGS ALLOWED, SOLD OR DISPLAYED. NO EXCEPTIONS. IF IT IS ILLEGAL, DO NOT BRING IT!

THE VENDOR COORDINATOR WILL SET UP THE VENDOR ARENA TO BEST ACCOMMODATE THE PRODUCTS AND SELLERS.

Vendor applications are considered complete when STRUTZFEST receives all documents, payment and requested materials. Vendors may not set up at the event until all conditions are met. All Vendors will receive wristbands prior to the event from the Vendor Coordinator. Wristbands will NOT be available at the gate or event. Vendors must have wristband on wrist to enter festival grounds for set up. NO WRISTBAND, NO ENTRY.

Vendors will comply with all laws and regulations. Vendor is responsible for obtaining necessary permits, licenses and insurance in order to operate and/or sell at this event. All licenses and insurance forms must be on display at the Vendors booth space. Vendor's spaces may not be split, shared, resold or sublet. Theft and loss is the responsibility of the Vendor. No exclusives promised, however, a well diversified group of FOOD AND CRAFT VENDORS are desired.
